It was truly a great pleasure meeting you and I commend you on running an absolutely fantastic conference. I made several notes while I was at the conference that I intended to pass onto you but have since misplaced them. Notwithstanding that fact, the conference made such a wonderful impression on me, that it should not be a problem sharing my thoughts with you in this e-mail.

By way of background, I have been practicing law for just over 17 years. During this time, I have attended dozens and dozens of conferences on a variety of different legal topics. I can say without hesitation, that the Partnering for Compliance conference was far and away the best conference that I have ever attended.

As I mentioned to you at the conference, I have worked as an in-house counsel for my entire career. This means that when I attend conferences, I am looking to learn as much as possible about the subject matter of the conference so that I can bring the knowledge in-house and share it with my colleagues. I always hoped that the cost of the conference would be offset by the savings we would realize in not having to go to outside counsel for advice. Inevitably, the law conferences were about self-promotion for the sponsors of the conference. The speakers would typically give you tidbits of information with the sole

intention of having you retain them after the conference and pay them to get more information.

The only conferences that I ever attend that are not about solicitation are the BIS conferences. While full of information, the BIS conferences have two major problems. The first problem is that the speakers use a tremendous amount of jargon and acronyms assuming a certain level of understanding on the part of the people attending the conference. To the novice, they would often be lost in the very first minutes of the seminar which undermines the primary purpose of the conference. The second problem is that the other purpose of the BIS conferences often appears to be intimidation. If I think back to the first BIS conference that I ever attended, I remember walking out of there worrying that the wrath of the Lord was going to come down on me unless my client was strictly compliant.

Partnering for Compliance was unlike any conference that I have ever attended. The sensitivity to the comprehension of the participants was exceptional. Barb's words about the four things you must always do are still resonating in my brain. What was also amazing was the way in which the organizers of the conference were able to extract the most out of the speakers. Each and every speaker seemed delighted to be there. They were relaxed and human. They showed a side to themselves that I have never seen before from Government speakers. They also seemed to be legitimately helpful. They were able to provide insight into the whys and hows about trade compliance that I have never seen before.

What was most apparent about the conference was the fact that as a participant, I felt really taken care of by the organizers. The entire team was sensitive to every need of the audience and committed to having every participant take something away from the conference. This was particularly true of you and Barb. While Barb and I have known each other for a little while, I really saw a different side to her at this conference. In fact, I cannot put it any more bluntly than "she blew me away". I am grateful to know her and now you.

I very much liked the flexibility that was shown by having both cards and microphones for questions. If someone was afraid to speak, they could record their question anonymously on the cards. That was brilliant.

I also liked the fact that the forum for the event was at a university. What better place to have a conference than an institution for higher learning! It felt really nice to be back on campus.

I am truly struggling to find things that might improve the conference. The only thing that comes to mind is maybe to have more interactive sessions. It might be beneficial to break

people into smaller groups for directed discussions led by experts in their fields. People might benefit from having more focused discussions on topics with their peers and expert.

The only other suggestion I can think of is possibly running the conference quarterly in different parts of the country. The conference was very reasonably priced but if you hold them in major metropolitan areas like New York, Boston, Philadelphia, Washington, Chicago, Seattle, Los Angeles and Silicon Valley, you will attract people who can drive to the conference and not incur the air and hotel fees. Some companies are very frugal with expenses and local conferences are often very attractive to people who don't have travel budgets. In fact these are often the same small to medium sized companies who you are trying to appeal to.

I am very sorry for sending such a long e-mail but I really hope that you will be able to extract a few worthwhile things from this dissertation.

Probably the biggest compliment I can pay to you and Barb about this conference is that while I was waiting for my flight back to New York after the conference, I booked a hotel for next year's conference.
